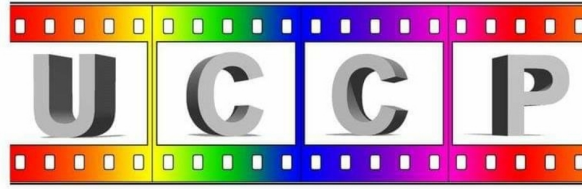
## AUTHORIZATION TO REPRODUCE PHYSICAL LIKENESS, VOICE, AND OTHER SOUNDS

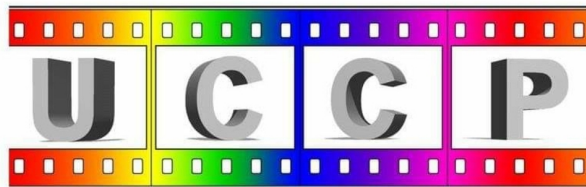
