PARENT/GUARDIAN CONSENT FORM


AUTHORIZATION TO REPRODUCE PHYSICAL LIKENESS, VOICE, AND OTHER SOUNDS

For good and valuable consideration, the receipt of which **Unlimited Creative Corporations (UCCP)** (Producer/Production Company) is acknowledged, I hereby grant to said (Production Company) and its board members, employees, agents, and assigns, the right to photograph me and use my picture, silhouette, and other reproductions of my physical likeness (as the same may appear in any still camera photograph and/or motion picture film or videotape recording) in and in connection with the exhibition, theatrically, on television or otherwise, or manufacture of videocassettes or DVD's, of any motion pictures or videotape recordings in which the same may be used or incorporated, and also in advertising, exploiting and/or publicizing of any such streaming, videos, tik toks, motion pictures, etc, but not limited to television, radio, streaming services, or theatrical motion pictures. I further give (Production Company) the right to reproduce in any manner whatsoever any recordings made by (Production Company) of my voice and all instrumental, musical or other sounds produced by me.

Videos do not need to include your child's face or voice; different styles are accepted, including live action, Claymation, digital animation, stop motion, etc.


